The Zoning Board of Appeals of Schoolcraft Township will conduct a public hearing at a special meeting on Thursday, May 13, 2021 at 7:00 p.m. and consider any other business to come before the Board. This meeting and public hearing will be held at the Schoolcraft Township Hall, 50 East "WV" Avenue, Vicksburg, MI 49097, as well as electronically pursuant to the Open Meetings Act, the Kalamazoo County Local State of Emergency and the Michigan Department of Health and Human Services (MDHHS) Emergency Order (see further guidance below).

At this meeting, the Zoning Board of Appeals will consider and hold a public hearing on the following matter:

Variance request submitted by Steve Slesinski (the "Applicant") involving property located at: 14811 North Barton Lake Drive, Vicksburg, MI 49097 (Parcel No, 14-23-360-691).

The Applicant is requesting the following variance:

- Article/Table 20 Setback Requirements to raise the roof on the home/ceiling height from 7 feet to 9 feet and roof peak height from 13'33" to 23'4".
- Article 27 Section 27.3 for an alteration to a non-conforming building.

Pursuant to the Open Meetings Act, Act 267 of 1976, and the MDHHS Emergency Order, the Zoning Board of Appeals gives notice of the following:
